#### HDMC Closure by December 2027





Since opening in 1975, major renovations at HDMC have not been possible:

- Design does not allow for phased renovations patients and staff must vacate for <u>up to</u>
   24 months for any major repairs.
- 2. Extensive renovations will trigger new code requirements for recertification.



#### Anticipated Locations as of May 14, 2025




# Of the 33 patients currently at HDMC:

- **SEVTC Availability** SEVTC has 15 five-bed homes on its campus for individuals with intellectual disability (ID). SEVTC has beds to accommodate individuals with ID transitioning from HDMC.
- Need 15 individuals at HDMC with ID have not identified new placements. Some of these families stated they are more likely to choose community care. DBHDS believes 5 families would choose care at SEVTC. DBHDS anticipates renovating two homes will meet the immediate need.
- Staffing Augmentation DBHDS needs to upskill existing staff and hire additional staff to meet certification requirements for skilled nursing beds.

## Types of Community Placement Options

Private Intermediate Care Facility for I/DD	Residential facility with active treatment, ongoing evaluation, planning, 24-hour supervision, coordination, and integration of health/rehabilitative services.
Sponsored Residential Home	Family home with 1-2 individuals with contractual agreement with a licensed agency to provide oversight and administrative services. Some support complex medical needs.
Group Home (I/DD or MH)	Home with 24-hour supervision and support to 3 or more people. May use Medicaid waivers for skilled or private duty nursing services and behavioral health and other support.
Options for serious mental illness, dementia, or other neurocognitive disorder	Services in a private facility or specialized mental health group home that provides medical support.  • Specialized group homes and memory care facilities  • Behavioral support in private nursing facilities

- 3 subgroups were formed and have been meeting monthly
- Some subgroups will meet bi-monthly over the Summer
- Participants may submit information for subgroups to review/discuss/consider.
- Meetings are open to the public
- All meetings are recorded and posted publicly



# DBHDS>>>

- 1. **Supporting Patients** Transition of individuals receiving services in the state facility to services in the locality of their residence prior to admission or the locality and setting of their choice after discharge.
- 2. **Supporting Staff** Resolution of issues relating to the restructuring implementation process, including employment issues for state employee transition planning and appropriate transitional benefits.

#### 3. Building and Enhancing Community Services

- Types, amounts, and locations of new and expanded community services needed to successfully implement the facility closure
- Implementation plan for community services infrastructure for current and future capacity needs
- Creation of new and enhanced community services










#### Potential Closure Timeline
