#### **Updates**

#### • Investigator Training Verification

The Office of Human Rights continues to verify that each provider has a Trained
Investigator which is a regulatory requirement of 12VAC35-115-175 (F)(4). Through this
verification process we have been able to identify several providers that have not be in
compliance with this regulation. To ensure compliance we have referred the provider to
complete the Investigating Abuse, Neglect and Exploitation training that is offered
through this office.

- Our office continues recruitment effort for members to join our LHRC'S. We currently have 3 Local Human Rights Committees for the community in Region 5
  - Health Planning Region 5 which meets at the Norfolk Community Service Board quarterly on the 3<sup>rd</sup> Monday @ 1:00pm
  - Southeastern Regional LHRC which meets at the James Barry Robinson Institute quarterly every third Wednesday @9:30 am
  - Southeast Alliance LHRC which meets at the Riverside Mental Health & Recovery Center quarterly on the 3<sup>rd</sup> Tuesday @ 12:00pm

- Health Planning Region 5 may have a new member that will be joining our team. We are
  waiting the confirmation of the SHRC in August. Once they have been confirmed we will

### **CLOSED SESSION:**

Motion was made by Michelle Logan and seconded by Christy Kieschnick at 1:26pm that the HPR5 LHRC will go into closed session pursuant to VA code 2.2-3711 (A), for the purpose of discussing confidential information lawfully exempt from public disclosure review to discuss Restrictions of Everyday Freedom and conduct LHRC interviews.

# **RETURN TO OPEN SESSION:**

The committee reconvened in open session at 3:09pm by unanimous vote on a motion by Michelle Logan and seconded by Christy Kieschnick. Each member certified that, to the best of each of their knowledge, only private business matters, lawfully exempted from the statutory open session requirements and identified in the motion by which the closed session was convened, were considered in the closed session, namely for the purposes to discuss a Restriction of Everyday Freedom and conduct LHRC interview.

Recommendation: Motion made by Michelle Logan, seconded by Ms. Christy Kieschnick and unanimously approved by the committee members as follows:

- 1.) Camera and Video restrictions were not approved by the LHRC for JO as additional information was required. LHRC recommended that the provider provide evidence that the documented less restrictive alternatives were attempted. to include:
  - A. Provide evidence that the documented less restrictive alternatives have been attempted by a qualified professional
  - B. Copy of JO behavioral Support plan

- C. Information regarding supports that are utilized when JO began to engage in head banding behavior.
- 2.) Camera restriction was approved by the LHRC for GC. LHRC recommended that the provider return with a quarterly update to discuss implementation.
- 3.) The restriction request for mittens, body suit and chest harness were approved for PJ. LHRC recommended that the provider return with a quarterly update to discuss implementation.
- 4.) LHRC voted to recommend appointments to the SHRC for Palmer and Rhodes to be appointed to the Health Planning Region 5 LHRC
